## **2018 – THE YEAR AHEAD FOR VISTA CENTER**

**As we turn the calendar to January, as individuals and as an agency, we tend to look back briefly for turning points in the past year and also set priorities for the year ahead. 2017 brought many exciting and landmark changes for our agency and the clients we serve.**

- **Palo Alto Moves to Permanent New Home at 2500 El Camino Real**

**In May, we finally moved into our brand new building and are located on the ground floor in a state of the art below-market-rent housing community. We worked with our architect and contractors to create an accessible ground floor space that meets the needs of our clients, volunteers, staff and community. We held a series of open house gatherings in our open and spacious facility which were enjoyed by staff, clients and donors. New signage is prominently located at the front and rear entrances and we are thrilled to be back in the midst of California Avenue and all that it offers to us. - **Santa Cruz Builds Community in New Location**

**In November of 2016, our Santa Cruz team moved into our new location at 3315 Mission Drive, Suite B, Santa Cruz. Christy Tall was hired as the new Branch Manager and she is assisted by a dynamic team of paid and volunteer staff. The team is working hard to build community connections and the Access Technology Program is robust. One significant goal for the team is to increase clients served by 30%, and the outreach efforts are contributing to the achievement of this goal. The team has developed the Santa Cruz version of our agency recreation program, titled Shared Paths. In Santa Cruz and Palo Alto, our clients get together for hikes, audio-described live theater, kayaking adventures and opera outings. This program will continue to grow in 2018. Vista Center Santa Cruz is rapidly becoming the go-to place for blind and visually impaired community members in Santa Cruz County.**

- **Pending Merger with the Santa Clara Valley Blind Center**

**An exciting development is coming to fruition in 2018; the merger of Santa Clara Valley Blind Center, located on Bascom Avenue in San Jose, to become the third branch of Vista Center.**

**SCVBC programs are primarily social/recreational and an excellent fit with Vista Center's broad array of rehabilitation services. In addition to our similar missions, Blind Center staff share our organizational values and dedication to meeting the needs of clients. The final details are almost complete and we anticipate the process to be fully completed soon. All three of the Vista Center branches will offer the same array of programs and services and the building**

located in San Jose will provide us with an expanded opportunity to host events and offer recreation programs. This is an exciting development for all of the clients we serve in Santa Clara County, as well as our San Mateo County clients. - **Priorities for 2018**

Looking ahead, we have several priorities that are designed to help us continue our mission of serving existing and potential clients. Listed below are several of the highlights for our priorities:

By June 2018 Vista Center will have three smoothly functioning and fully integrated branches in Palo Alto, Santa Cruz and San Jose. We will have plans in place for achieving financial sustainability while expanding programs/services in San Jose, in particular, increasing our visibility, encouraging the professional development of all staff and establishing collaborative relationships throughout our service area.

Continue innovations in our Technology Program. We have a very robust technology program in all three locations and this will continue to be a priority for our agency. The Access Tech teams in all three branches will continue to work together and share best practices for bringing access technology to the lives of the clients we serve.

We will expand Technology for Youth in the classroom and with our new program Vision for Our Youth Tomorrow in Santa Cruz.

**We will continue to Expand Social/Recreation in all three locations via Shared Path program.**

**We will replicate Palo Alto services in San Jose, including The Store and Choices & Changes, a series of classes to help individuals adjust to vision loss.**

**We plan to add our inventory list from the Store to our website. Existing clients, potential clients and family members will be able to view a list of items sold at The Store to make it easier to learn about available products.**

**The year ahead will bring new opportunities and challenges to Vista Center. We are committed to using the best practices in providing our core services, while strongly encouraging innovation, creativity and enhanced or updated methods for providing ongoing services.
